## **STATE PARK RULES AND REGULATIONS**

1. Shelter reservations are subject to all statues and administrative rules governing the park, which are posted at the site. Any violations will result in the revocation of this permit and denial of future requests.
2. You must be at least 18 years of age to rent any shelter.
3. Shelter use hours are from 7:00AM until 10:00 PM.
4. It is unlawful to possess alcoholic beverages in containers capable of holding more than one gallon.
5. Reservation Fee (\$25.00) for one day, must accompany application.
6. Reservation Fees are non-refundable unless area is closed by the Department of Natural Resources.
7. Make check payable to **IDNR - Illinois Department of Natural Resources.**
8. It is the responsibility of the person(s) making the reservation to pick up all garbage and litter and to dispose of it in the proper containers. Anyone not complying with this rule may be subject to a fine for littering.
9. Vehicles including mopeds, motorcycles and all other vehicles must be kept on designated parking areas.
10. No tents are permitted.
11. If you move the picnic tables from the shelter, you must move them back under the shelter.
12. No swimming is permitted within Eldon Hazlet State Park except at the public pool in the campground.
13. We are not responsible for any additional amenities, we only provide the shelter and picnic tables.
