**INSTRUCTIONS & INFORMATION:**

1. Application for this type of license must be filed with the Department between March 1<sup>st</sup> and September 1<sup>st</sup>.
2. Include a check payable to the Illinois Department of Natural Resources for \$100 - Class A License - Hunting Season: Sept. 1<sup>st</sup> - April 15<sup>th</sup> or for \$200 - Class B License - Hunting Season: All Year.
3. Include a Plat Map and an aerial photograph with the proposed hunting preserve property highlighted or the boundaries outlined.
4. If the proposed hunting preserve or any part of the proposed hunting preserve property is leased, a copy of the lease(s) must be received by the Department before the hunting preserve license will be issued. The term of the lease must be five years.
5. Property included in a licensed hunting preserve must contain at least 200 contiguous acres and cannot contain more than 1,280 contiguous acres. The proposed hunting preserve must also contain at least 100 acres of suitable wildlife habitat.

By signature above I declare under penalty of perjury that the information provided is true and correct, and I am not more than 30 days delinquent in complying with a child support order. Making a false statement may subject you to contempt of court. I further acknowledge that providing false or deceptive information in applying for this license is a violation of law and may subject me to arrest and the revocation on my license privileges for a period of up to five years (ICS Ch. 515, pars. 5/20-105 and 5/20-120 and Ch. 520, pars. 5/2.38 and 5/2.36)
