- MEADOWVIEW I (electricity, water, playground, horseshoe pit, volleyball, basketball court nearby)
- MEADOWVIEW II (on hill; water, playground near Meadowview I available to all visitors using shelters)

- RED PINE (between Lakeview Hill and campground)
