This reservation is made with the understanding that the following regulations must be adhered to, as must all statutes and administrative orders governing the park. Any violations may result in the group's eviction and denial of future requests.

1. One responsible adult (18 years of age or older) must accompany each group of 15 or less campers under the age of 18.
2. All litter and refuse from your outing must be deposited in the provided containers. Please keep your area clean and in an orderly condition.
3. Grills and fire rings are provided for fires. Wood found on the ground is for park use only. Felling any tree and the use of chain saws is prohibited.
4. Please remove any flagging prior to departure. Blazing of trees with axes is also prohibited.
5. As the park closes at 10 p.m., visitors must depart at that time.
6. Please restrict noise to your area. Quiet hours begin at 10 p.m.
7. All types of firearms, including BB guns, are prohibited.
8. Directional signs posted in the park by your group will be immediately removed by park staff.
9. Vehicles are not permitted out of the parking lot at Long Point.
10. It shall be unlawful for any person to possess or consume alcoholic beverages in both group camp areas.

My signature signifies that I have read and understand the above rules. I understand that I am responsible for the actions of the group and the condition of the group camp while it is in our use. I acknowledge that future use of the facility may be refused should our group violate any of the regulations.
