INSTRUCTIONS FOR COMPLETING FORM FPF-1

1. Name in which license is issued or landowner harvesting own timber. Address should include street, city, state and zip code. County in which License Holders address is located. Authorized agents must use license holder's name when negotiating or buying timber. License under which timber is purchased must be indicated on any written contract.
2. Illinois timber buyers license number and year of issue.
3. Check Quarterly Report (Jan/Mar - April/June - July/Sept - Oct/Dec) Or Check Individual Report.
Individual Report - Buyers may report each timber purchase individually at any time after purchase is made. Quarterly reporting deadline requirement must be met.
Quarterly Report - Timber purchases must be reported quarterly. All purchases made within a quarter must be reported by the last day of the month, following the end of the quarter. All purchases should be submitted together when filing a quarterly report.
NOTE: Submit only quarterly or individual reports in any one quarter. When submitting less than three purchases on a sheet, do not cut off unused portion.
4. Name and complete address of timber owner. NOTE: If harvesting own timber, buyer and owner will be the same.
5. Total dollars paid (including harvest fee) x .04 = State Harvest Fee.
6. Indicate the date an agreement to purchase the timber was made, e.g. the date of the contract.
7. Indicate the date the timber was paid for. Also circle the appropriate type of payment full or partial. Circle full payment if the full purchase price was paid to the owner in the same Quarter the agreement to buy was made. Circle partial payment if only a portion of the purchase price was made in the same Quarter as the agreement to buy was made or payment(s) are going to be made in subsequent quarters.
8. Timber origin: County, Legal Description (Section, Township, Range).
9. Check only as appropriate.
10. Signature of person(s) submitting form.
